Meeting Call to Order- Meeting was called to order at 12:10.

Approval of Minutes -

- 1. Blackduck Chamber Marketing
 - a. Webcam for TIC- Currently on hold, the technology needs to be temperature controlled, possible option to put equipment in the firehall?
 - b. WTH is Blackduck Promotion The Pond Pint Glasses- Continuing to find options for this, needing to visit with community members, Lundberg mentioned that the first logo sold better than the second one. It was discussed if there should be a contest in Blackduck to design the new logo to help gain community buy in and involvement, once a winner was selected, work with Pinnacle to refine design. It was brought up by Rossberg if others found the word hell to be inappropriate, if there's feedback from community members around this, please bring it forward. Create design and gain community location commitments so it can be submitted to vendors in February/March to have product by mid April to have out. Max will start and reach out to Shawnda on the pond for their involvement
 - c. E-Newsletter- Need to have Kian to update with new leadership and will take new board members pictures in January. Invoice from the city for \$1245.90 to reimburse them for Kian's time. Vacek will send a message out thanking officers for their time and support and welcoming the new officers

 - e. All previous leadership is open and willing to help those taking over for any questions and needs to make the transition as smooth as possible.
