- 1. Blackduck Chamber Marketing

Klaers will collect information from businesses, Parker will complete write up, Pinnacle will provide photos and all the information will go to Winnett to submit to Bemidji Chamber by deadline of March 8<sup>th</sup>.
- 2. <u>Chamber Bingo First time was a success, had a good turn out. Chris Vacek sent information on a PA system, cost is roughly \$200, Klaers requested a motion to purchase the PA system, Lahr moved to purchase it, Rossberg seconded, motion passed unanimously.</u>
